## What is this product?

Eastspring Investments – World Value Equity Fund is a sub-fund of Eastspring Investments which is an open-ended investment company registered in Luxembourg. Its home regulator is Commission de Surveillance du Secteur Financier ("CSSF"), Luxembourg.

## **Objective and Investment Strategy**

## **Objective and Strategy**

The Sub-Fund aims to maximize long-term total return by investing primarily (at least 66% of the Sub-Fund's net assets) in global equity, equity-related securities, exchange traded funds and other collective investment schemes (including sub-funds of the SICAV). Equity-related securities in which the Sub-Fund may invest include but are not limited to listed securities in recognised markets<sup>^</sup>, depository receipts, including ADRs and GDRs, debt securities convertible into common shares, preference shares and warrants. ADRs and GDRs that the Sub-Fund may invest in will not have embedded derivatives.

The Sub-Fund may invest up to 100% of its net assets in other collective investment schemes and/ or exchange traded funds, which will have similar investment objectives and/or strategies as the Sub-Fund, but the exposure to any single collective investment scheme or exchange traded fund will be up to 20% of the Sub-Fund's net assets. The Sub-Fund will only invest in aggregate 30% of its net assets in other collective investment schemes and/or exchange traded funds which are not UCITS.

The Sub-Fund is not subject to any limitation on the portion of its net assets that may be invested in any one country, sector or any companies with a particular market capitalisation. Subject to the above strategy, from time to time, the Sub-Fund may invest more than 30% of its net assets in any one single country or region globally, such as the US and Europe.

The Sub-Fund may use financial derivative instruments ("**FDIs**") for hedging and efficient portfolio management purposes.

\* Recognised markets mean a regulated market, which operates regularly and is recognised and open to the public.

#### Benchmark

This Sub-Fund aims to outperform the return of MSCI World Value Weighted Index ("**Benchmark**"). The Sub-Fund is actively managed. The Benchmark has been selected because it is representative of the investment universe of the Sub-Fund and it is therefore an appropriate performance comparator. The majority of the Sub-Fund's equity securities will not necessarily be components of, or have weightings derived from the Benchmark. The Investment Manager may use its discretion to overweight or underweight certain components of the Benchmark and may invest in companies or sectors not included in the Benchmark in order to take advantage of specific investment opportunities. It is thus expected that the performance of the Sub-Fund will materially deviate from the Benchmark.

## Use of derivatives/investment in derivatives

The Sub-Fund's net derivative exposure may be up to 50% of the Sub-Fund's Net Asset Value. **What are the key risks?**

#### 1. General Investment Risk

• The Sub-Fund's investment portfolio may fall in value due to any of the key risk factors below and therefore your investment in the Sub-Fund may suffer losses. You may not get back your original investment. Past performance is not a guide to future performance. The level of investment return is not fixed and will vary.

#### 2. Equity Market Risk

• The Sub-Fund's investment in equity securities and equity-related securities is subject to general market risks, whose value may fluctuate due to various factors, such as changes in investment sentiment, political and economic conditions and issuer-specific factors.

#### 3. Risk of Investing in Other Collective Investment Schemes and Exchange Traded Funds

- The Sub-Fund will be subjected to the risks associated with other collective investment schemes and exchange traded funds in which it may invest. The Sub-Fund do not have control of the investments of such collective investment schemes and exchange traded funds and there is no assurance that the investment objective and strategy of such collective investment schemes or exchange traded funds will be successfully achieved which may have a negative impact to the net asset value of the Sub-Fund.
- Other collective investment schemes or exchange traded funds in which the Sub-Fund may invest may not be regulated by the SFC. There may be additional costs involved when investing into such collective investment schemes and exchange traded funds. There is no guarantee that such collective investment schemes or exchange traded funds will always have sufficient liquidity to meet the Sub-Fund's redemption requests as and when made.

### 4. Concentration Risk

- Although the Sub-Fund is a global fund, the Sub-Fund's investments may be concentrated in a specific geographical location, such as the US or Europe. The value of the Sub-Fund may be more volatile than that of a fund having a more diverse portfolio of investments.
- The value of the Sub-Fund may be more susceptible to adverse economic, political, policy, foreign exchange, liquidity, tax, legal or regulatory event affecting the relevant market.

#### 5. Liquidity Risk

• The Sub-Fund may have investments which have liquidity risks (for example, low trading volumes), and may incur substantial losses if it is unable to sell these investments at opportune times or prices.

#### 6. Eurozone Specific Risk

 In light of ongoing concern on the sovereign debt risks of certain countries within the Eurozone, the Sub-Fund's investments in the region may be subject to higher volatility, liquidity, currency and default risks. Any adverse events, such as credit downgrade of a sovereign or exit of EU members from the Eurozone, may have a negatively impact on the net asset value of the Sub-Fund.

#### 7. Small-capitalisation/Mid-capitalisation Companies Risk


 The Sub-Fund may invest in securities of small-capitalisation/mid-capitalisation companies which may have lower liquidity and their prices are more volatile to adverse economic developments, than those of larger capitalisation companies in general, as a result of inadequate trading volume or restrictions on trading and this may result in fluctuations in the price of the shares.

#### 8. Currency and Exchange Rates Risk

• The assets that the Sub-Fund invests in may be denominated in currencies different from the Sub-Fund's base currency and the currency of the shares held by you. The net asset value of the Sub-Fund may be affected unfavourably by adverse movements in foreign currency exchange rates between the currencies of the underlying assets and the base currency of the Sub-Fund and the currency of the shares held by you, as well as by changes in exchange rate controls.

#### 9. Derivatives Risk

- Derivatives involve risks different from, and, in some cases, greater than, the risks presented by more traditional securities investments. Some of the risks associated with derivatives are market risk, management risk, credit risk, counterparty risk, liquidity risk, volatility risk, operational risk, leverage risk, valuation risk and over-the-counter transaction risk.
- The Sub-Fund may use FDIs for hedging and efficient portfolio management purposes, however, the Sub-Fund's use of derivatives may become ineffective in such endeavours and the Sub-Fund may suffer significant losses.

However, before placing your subscription or redemption orders, please check with your distributor for the Sub-Fund's valuation day and the distributor's internal dealing cut-off time (which may be earlier than the Central Administration Agent's dealing cut-off time). You may also check with the Hong Kong Representative regarding the Sub-Fund's valuation day.
