Important Information

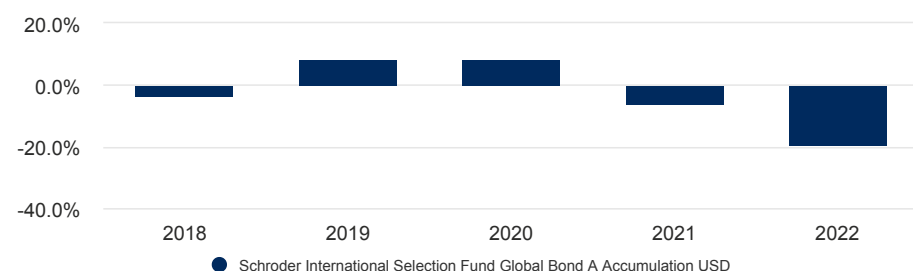
The fund maintains a higher overall sustainability score than its sustainability benchmark based on the investment manager's rating system.

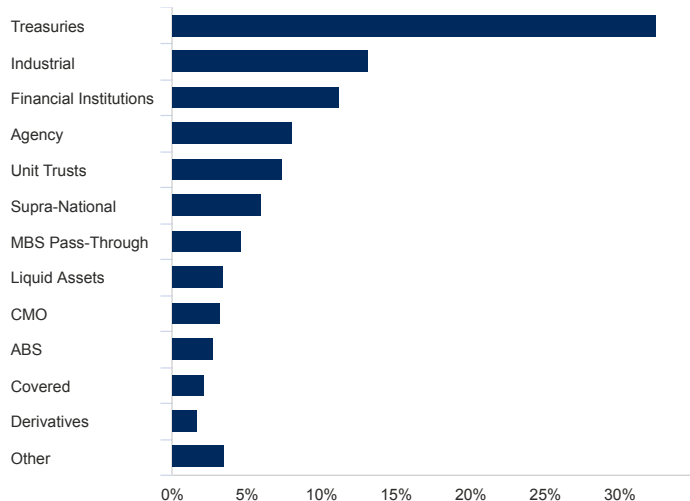

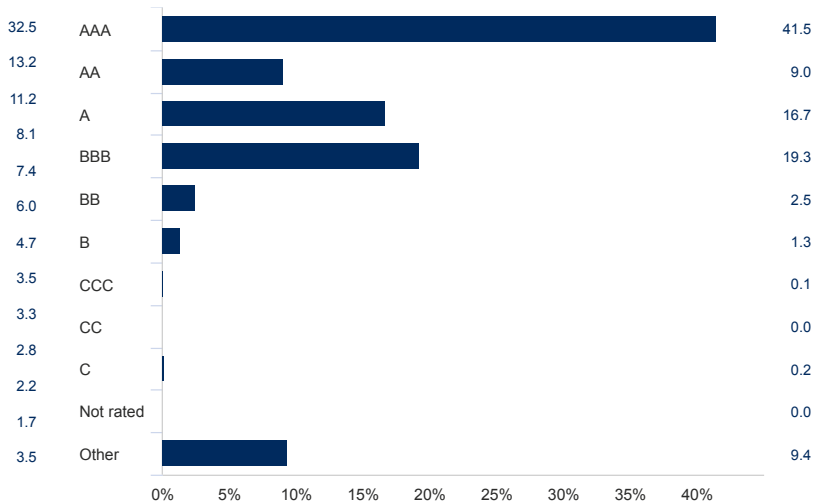

Credit quality (%)

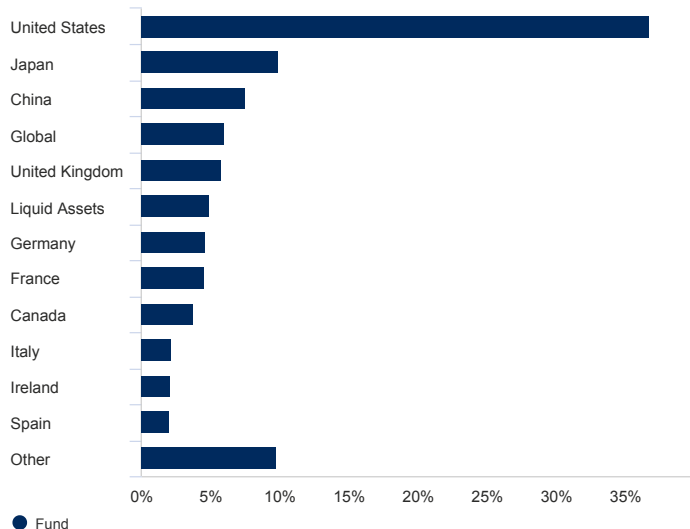

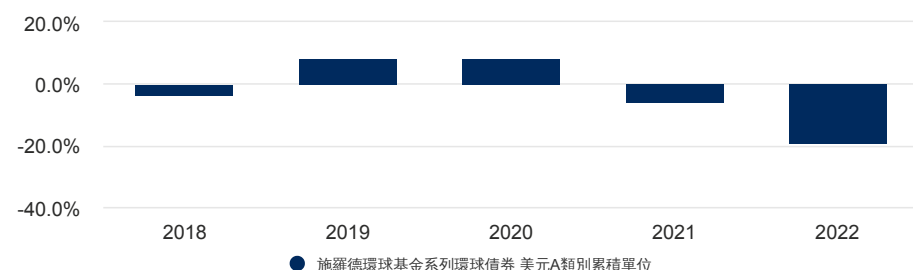

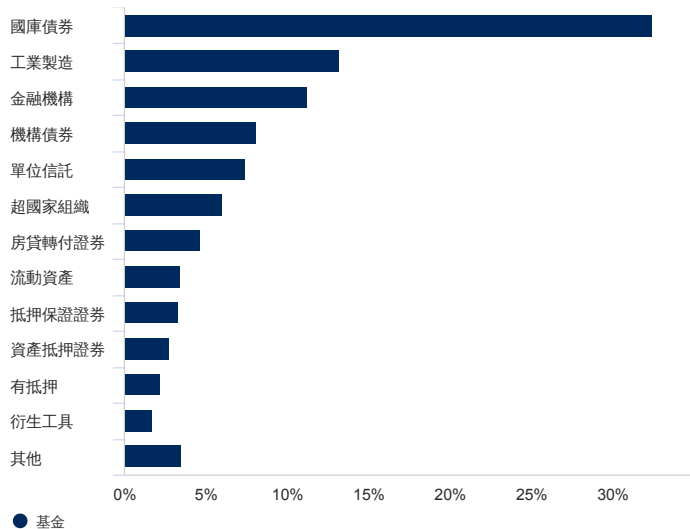

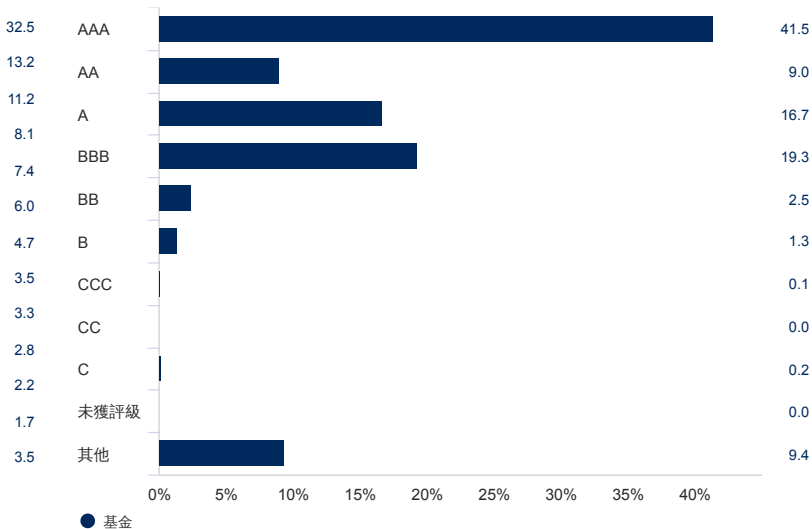

行業資產分佈 (%)

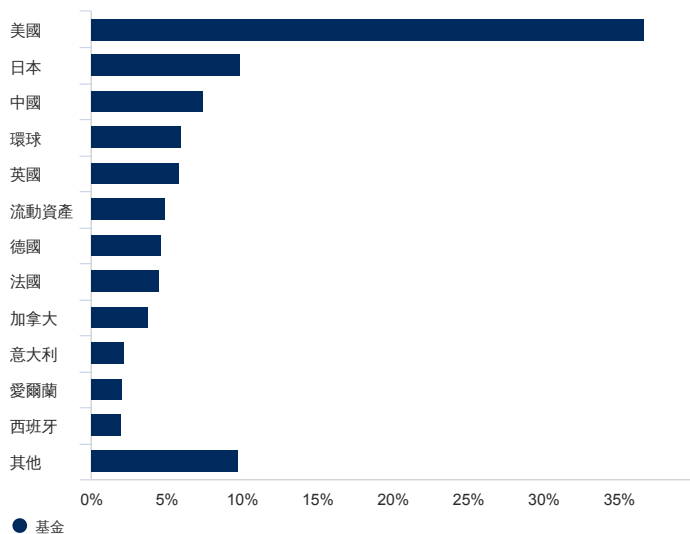
