

# Fidelity Funds - Asian Special Situations Fund 富達基金-亞洲特別機會基金



The fund aims to achieve capital growth over time. The fund invests at least 70% (and normally 75%) of its assets, in equities of companies that are listed, headquartered or do most of their business in Asia (excluding Japan), which may include emerging markets. The fund seeks to invest in special situations equities (equities that generally have attractive valuations compared to their earning potential) and in equities of smaller growth companies. The fund may also invest in money market instruments on an ancillary basis. The fund invests at least 50% of its assets in securities companies with favourable environmental, social and governance (ESG) characteristics. 
