

Important Information

- The Fund invests primarily in a diversified portfolio of equities or equity-related securities of companies with their registered office in a European country or exercising their business activities predominantly in European countries which are listed on recognized European stock exchanges and which meet the Fund's ESG criteria with a particular focus on environment issues.
- Investors should note ESG investment risk, the risk of Eurozone crisis, concentration risk of investing in European companies which meet the Fund's ESG criteria with a particular focus on environment issues, volatility risk, currency exchange risk, equities risk, and general investment risk.
- Financial derivative instruments (FDI) may be used for efficient portfolio management purposes or to hedge or reduce the overall risk of investments. Risks associated with FDI include counterparty/credit risk, liquidity risk, valuation risk, volatility risk and over-the-counter transaction risk. - In addition, investors of Monthly Distribution-1 share class that are currency hedged (MD-1 hedged) should be aware of the uncertainty of relative interest rates. The net asset value of the MD-1 hedged may fluctuate and may significantly differ from other share class due to fluctuation of the interest rate differential between the currency in which the MD-1 hedged is denominated and the base currency of the Fund and may result in a greater erosion of capital than other non-hedged share class. Objectives and investment strategy

The Fund aims to achieve long-term capital growth. The Fund seeks to achieve its objective by investing primarily (at least 70% of its net asset value) in a diversified portfolio of equities or equity-related securities of companies: with their registered office in a European country or exercising their business activities predominantly in European countries which are listed on recognised European stock exchanges, and which meet the Fund's environmental, social and governance (ESG) criteria with a particular focus on environmental issues.

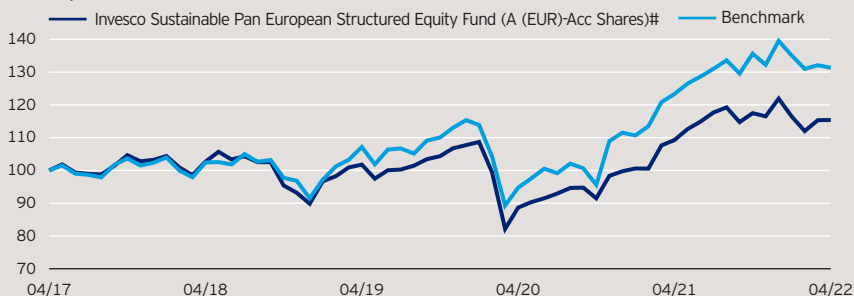
