



# Fidelity Funds - Global Financial Services Fund 富達基金-環球金融服務基金

- This fund invests primarily in the equity securities of companies throughout the world which are involved in providing financial services to consumers and industry.



# Investment Objective 投資目標

The fund aims to achieve capital growth over the long term. The fund invests at least 70% (and normally 75%) in equities of companies from anywhere in the world, including emerging markets, that provide financial services to consumers and industry. The fund may also invest in money market instruments on an ancillary basis. The fund invests at least 50% of its assets in securities of companies with favourable environmental, social and governance (ESG) characteristics. 基金旨在實現長線資本增長。基金將最少70%(通常為75%)的資產投資於世界各地(包括新興市場)向個人和企業提供金融服務之公司的股票。基金亦可在輔助基礎上投資於貨幣市場工具。基金將最少50%的資產投資於具有有 利環境、社會和管治(ESG)特徵之公司的證券。


