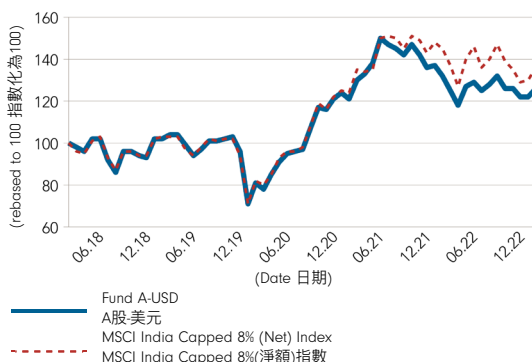
- This fund invests primarily in Indian equity securities.

Investment Objective 投資目標

The fund aims to achieve capital growth over the long term. The fund invests at least 70% (and normally 75%) of its assets, in equities of Indian companies listed in India, or non-Indian companies which do most of their business in India. The fund may also invest in money market instruments on an ancillary basis. The fund invests at least 50% of its assets in securities of companies with favourable environmental, social and governance (ESG) characteristics. 基金旨在實現長線資本增長。基金將最少70% (通常為75%) 的資產投資於在印度上市之印度公司的股票，或在印度進行大部份業務之非印度公司的股票。基金亦可在輔助基礎上投資於貨幣市場工具。基金將最少50%的資產投資於具有有利環境、社會和管治 (ESG) 特徵之公司的證券。

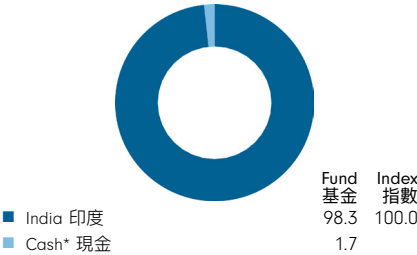

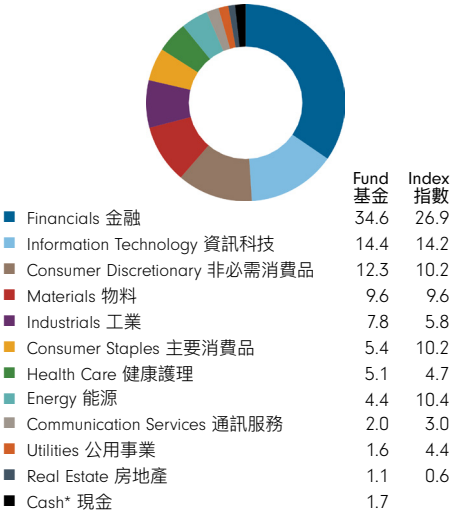
