



# Fidelity Funds - Asia Pacific Dividend Fund 富達基金-亞太股息基金

- This fund invests primarily in income producing equity securities in the Asia Pacific region.

  The fund is subject to equities risk, risk to capital and income, foreign currency risk and risks of investing in emerging markets. Although the fund will generally invest in income-producing securities, it is not augranteed that all underlying investments will generate income. Higher yields generally mean that there will be refor capital appreciation for equity securities.
- The use of ESG criteria may affect the fund's investment performance and may result in a return unfavorably to similar products without such focus. The ESG characteristics of securities may change over time, which may require the Investment Manager disposing of such securities when it might be disadvantageous to do so, which may lead to a fall in the fund's value. #### Investment Objective 投資目標

The fund aims to achieve capital growth over the long term and provide income. The fund invests at least 70% (and normally 75%) of its assets, in income producing equity securities of companies that are headquartered or do most of their business in the Asia Pacific region, including emerging markets. The fund may also invest in money market instruments on a ancillary basis. The fund invests at least 50% of its assets in securities of companies with favourable

environmental, social and governance (ESG) characteristics. The fund will invest less than 30% of its assets (directly and/or indirectly) in China A and B Shares (in aggregate).

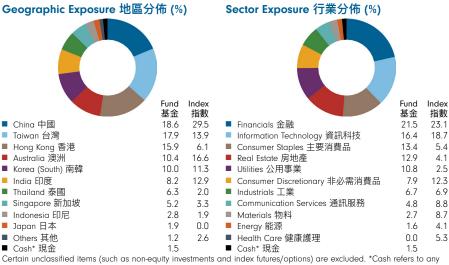
