

# Fidelity Funds - Emerging Market Debt Fund 富達基金-新興市場債券基金

- This fund invests primarily in global emerging markets debt securities.

  The fund is subject to risk to capital and income, foreign currency risk, risk of investing in sovereign debt, risks of investing in emerging markets and risks associated with debt securities, including Credit / Counterparty, Interest Rate, Downgrading, Valuation and Credit Rating Risk. The fund may invest in debt securities rated below investment grade or unrated securities which are subject to lower liquidity, higher volatility, heightened risk of default and loss of principal and interest than higher-rated/lower yielding debt securities. 

#### Investment Objective 投資目標

The fund aims to achieve capital arowth over time and provide income. The fund invests at least 70% of its assets, in emerging market debt securities issued by governments, quasi governments, banks, financial institutions and corporate entities. The fund may also invest in other types of debt securities, equity securities, lower quality debt securities and on an ancillary basis in money market instruments. The fund invests at least 50% if its assets in securities of companies with favourable environmental, social and governance (ESG) characteristics. The fund may invest in the following assets according to the percentages indicated: listed China onshore bonds (directly and/or indirectly): less than 30% (in aggregate); hybrids and contingent convertible (CoCo) bonds: less than 30%, with CoCos less than 20%. The fund may also invest in other subordinated financial debt and preference shares. The fund is unconstrained in the amount that if may invest in below investment grade securities or issuers. The fund's exposure to distressed securities is limited to 10%


