

## Important Notes 重要提示

- 1 Manulife Global Fund – U.S. Bond Fund (the “Fund”) invests in U.S. Dollars denominated fixed income securities with an intended average credit rating of A and above, which may involve geographical concentration, securitised products, sovereign debt, liquidity, credit downgrade, interest rate, credit and rating of investment risks and risks associated with investments in debt instruments with loss-absorption features (including Contingent Convertible Debt Securities).

## Investment Objective 投資目標

This Fund has, as its primary objective, the maximisation of total returns from a combination of current income and capital appreciation. To pursue this objective, this Fund will normally invest at least 75% of its net assets in U.S. Dollars denominated fixed-income securities with an intended average credit rating of A and above. Such fixed-income securities may be issued by governments, agencies, supra-nationals and corporate issuers. This Fund may invest up to 25% of its net assets in higher-yielding debt securities rated lower than investment grade (i.e. below Baa3 by Moody's or BBB- by Standard & Poor's or Fitch). This Fund will invest at least 70% of its net assets in issuers located in the United States.

本基金主要旨在盡量擴大現時收入及資本增值相結合的總回報，為達致此一目標，本基金通常將其最少75%的淨資產投資於預期平均信用評級在A級及以上、以美元計價的固定收入證券。該等固定收入證券可由政府機構、跨國組織及企業發行機構發行。本基金可將其不超過25%的淨資產投資於低於投資級別(即低於穆迪的Baa3或標準普爾或惠譽的BBB-)的高息債務證券。本基金會將其最少70%的淨資產投資於位於美國的發行機構。

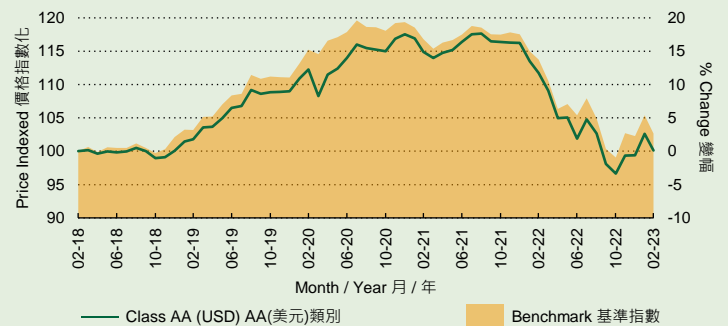
