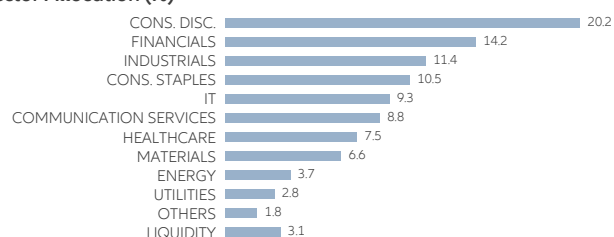

In 2010, there was a material change of the Fund's objectives and investment policy. Thus, the performances prior to 2010 were achieved under circumstances that no longer apply. On 23/12/2019, the Fund was renamed as Allianz Asia Innovation.)
