

## Important Notes 重要提示

- 1 Manulife Advanced Fund SPC - China A Segregated Portfolio (the "Fund"), which is denominated in United States Dollars ("USD") rather than Renminbi ("RMB"), uses a USD QFII quota to primarily invest directly in RMB-denominated China A-shares.
- 2 RMB is not freely convertible and is subject to exchange controls and restrictions. There is no guarantee that RMB will not depreciate. There are various requirements and restrictions under the laws of Mainland China and regulations relating to investment via QFII regime and/or China Interbank Bond Market that may expose the Fund to higher volatility, liquidity, emerging market and Mainland China tax and custodial risks.

## Investment Objective 投資目標

To achieve long-term capital appreciation by investing primarily in Mainland China capital markets. The fund seeks to achieve its investment objective by investing primarily (i.e. not less than 70% of its net assets) in companies listed on the A-Share markets of the Shanghai Stock Exchange and/or the Shenzhen Stock Exchange.
