- This fund invests primarily in income producing equity securities in Europe.

 The fund is subject to equities risk, risk to capital and income and foreign currency risk. The fund aims to achieve capital growth over the long term and provide income. The fund invests at least 70% (and normally 75%) of its assets, in income producing equities of companies that are headquartered, or do most of their business, in Europe. The fund may also invest in money market instruments on an ancillary basis. The fund invests at least 50% of its assets in securities of companies with favourable environmental, social and governance (ESG) characteristics.

The Investment Manager aims to provide income in excess of the benchmark.


