As the Sub-Fund may invest in A shares through ELIs, the Sub-Fund is therefore exposed to the risks relating to investment in ELIs: (i) Credit risk: If any one of the ELIs issuers fails to perform its obligations under the ELIs, the Sub-Fund may suffer losses potentially equal to the full value of the instrument issued by the relevant issuer. Any loss would result in the reduction in the Net Asset Value of the Sub-Fund and impair the ability of the Sub-Fund to achieve its investment objective.
- (ii)Illiquidity risk: There may not be an active market for those ELIs which are not listed or quoted on a market. Even if the ELIs are quoted, there is no assurance that there will be an active market for them. Therefore investment in ÉLIs can be highly illiquid.
- (iii)Qualified Foreign Investors/Qualified Investors or QI ("QI") risk: The Sub-Fund's exposure to the PRC market via ELIs depends on the ability of the QI to buy and sell A shares. - The Manager will normally make distributions out of net income received or receivable. However, in the event that the net income is insufficient to pay the distributions that it declares, the Manager may also, in its absolute discrétion, determine that distributions be paid out of capital, or the Manager may, in its discretion, pay distributions out of the gross income while charging/paying all or part of the fees and expenses to/out of capital, resulting in an increase in distributable income for the payment of distributions and therefore, the Sub-Fund may effectively pay distributions out of capital. This may reduce the capital available for investment in future and may constrain capital growth.

## **INVESTMENT OBJECTIVES AND POLICIES**

The BOCIP China Value Fund seeks to achieve long term capital growth by investing primarily in securities issued by or linked to companies which activities and business are closely related to the economy of the PRC.

The Manager will consider investment opportunities in all market capitalization ranges. The Manager would place particular emphasis on and will invest at least 70% of its non-cash assets in securities that are, in its opinion, with attractive values and investment in such securities will achieve the investment objectives of the Sub-Fund. Stock selection is based on "intrinsic valuation matrix" which seeks to identify companies with growth potentials, good fundamentals and/or attractive valuations. Fundamental factors may include business strategy, management strength and financial position. The Sub-Fund will mainly invest in Hong Kong-listed stocks, H shares, shares of red-chip companies (directly and/or indirectly through investments in SFC authorised collective investment schemes ("CISs") (including CISs managed by the Manager). The Sub-Fund is approved as "Eligible Collective Investment Scheme" under "Capital Investment Entrant Scheme" ("CIES") of Hong Kong Special Administrative Region ("HKSAR"). The HKSAR Government has announced that the CIES has been suspended with effect from 15 January 2015 until further notice. The Immigration Department of HKSAR ("Immigration Department") will continue to process applications received on or before 14 January 2015, whether already approved (including approval-in-principle and formal approval) or still being processed. #### MANAGER'S COMMENT<sup>##</sup>

- China's macro data of November shows both domestic and external demand remained on a weakening trend. Weakness in economic activity was broad-based amid the extended Covid disruptions.
- Meanwhile, the expectations of more pro-growth and reopening measures from the Politburo meeting and Central Economic Work Conference extended the positive sentiment and supported inflows to the market during the early period of December.
- However, the abruptly dismantle of Covid Zero policy by Beijing and the explosion in Covid infections across major cities thereafter overwhelmed the market. Market was in a new round of profit taking with small and mid cap stocks and growth factor suffered the major hit against such backdrop. Overall, Health Care and market reopening theme were the major market movers in the month
- National Health Commission announced to downgrade the management of Covid from Category A to Category B starting 8th January 2023. The earlier than expected border reopening will likely speed up the pace of economic restoration in the year. The upcoming waves of infection as we have seen in the reopening of other major economies are expected to weigh on China's economic activities in the 1H of 2023.
- The peak off of the current infection wave and pickup of mobility ahead of the CNY holidays will likely uplift sentiment and support inflows into the market in the near term.
