- This fund invests primarily in income producing equity securities globally.



The fund aims to achieve capital growth over the long term and provide income. The fund invests at least 70% (and normally 75%) of its assets, in income producing equities of companies from anywhere in the world, including emerging markets. The fund invests at least 50% of its assets in securities of companies with favourable environmental, social and

governance (ESG) characteristics. The fund may also invest in money market instruments on an ancillary basis.
