JPMorgan Investment Funds - Global High Yield Bond Fund

- The Fund invests primarily in global below investment grade corporate debt securities.
- The Fund is therefore exposed to risks related to emerging markets, debt securities (including below investment grade/unrated investment, credit and interest rate risks which may affect the price of bonds), currency, class currency, liquidity, derivative, hedging, currency hedged share classes, the Eurozone sovereign debt crisis and RMB currency. 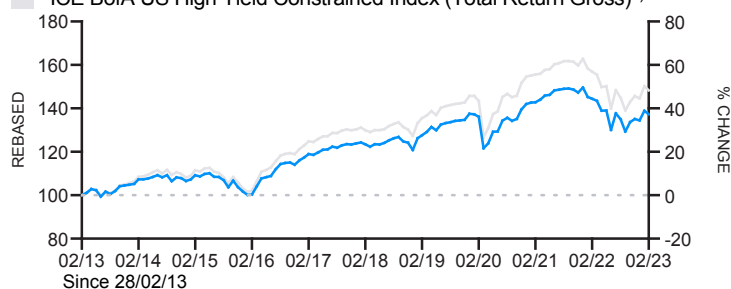
