FSSA Japan Equity Fund

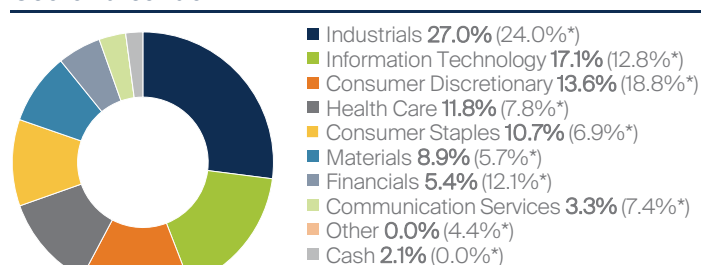
