- This fund invests primarily in investment grade Asian bonds.

  The fund is subject to risk to capital and income, foreign currency risk, risks of investing in emerging market, Chinese Renminbi currency and conversion risk, risk of RMB hedged share class and risks associated with debt securities, including Credit / Counterparty, Interest Rate, Downgrading, Valuation and Credit Rating Risk. Although the fund will generally invest in income-producing securities, it is not guaranteed that all underlying investments will generate income. 

#### Investment Objective 投資目標

The fund aims to achieve capital growth over time and provide income. The fund invests at least 70% of its assets, in investment grade debt securities of issuers that do most of their business in the Asian region, including emerging markets. The fund may also invest in money market instruments on an ancillary basis. The fund may invest in the following assets according to the percentages indicated: hybrids and contingent convertible (CoCo) bonds: less than 30%, with less than 20% in CoCos. The fund may also invest in other subordinated financial debt and preference shares.


