

經理人報告

Market Review

Chinese equity markets declined sharply in 2022 H2 amid weak corporate earnings results, slowing economic growth and regional Covid outbreaks. Geopolitical tensions also weighed on market sentiments. The markets then bounced back strongly approaching year end, as there was evident transition towards Covid policy relaxation since the 20 New Guidelines released, largely boosting the subdued market sentiments from relatively weak economic data releases.

Alongside with the attempts to finetune Covid policies, we have started to see signs of a re-focus on the economy from policymakers particularly around the property sector. The government has rolled out a set of measures to boost developer liquidity and facilitate the completion of existing projects under construction in order to support end-buyer confidence.

Chinese equity markets' upside momentum at the end of 2022 extended into H1 2023, as there were indications that the economy is rebounding, especially by the service sectors where pent-up demands were released post relaxations of strict Covid controls. The markets then oscillated downward from the January peak, and investor sentiments remained range-bound with all eyes on the recovery path, where uncertainties around the manufacturing and housing sectors still weighed on the markets.

市場回顧

中國股市在二零二二年下半年大幅下挫,原因是企業盈利業績疲弱、經濟增長放緩和區內新冠疫情肆虐,地緣政治緊張局勢也影響市場信心。市場其後在接近年終時強勁反彈,儘管新公布經濟數據相對疲弱,市場信心低迷,但自中國公布二十條新防控指引以來,新冠政策明顯轉向放寬,在很大程度上提升市場信心。

中國嘗試微調新冠政策的同時,我們已經開始看 到政策官員,特別是房地產行業的政策官員,他 們重新關注振興經濟。政府推出一系列措施提高 開發商的流動資金,促進現有在建項目竣工,恢 復用家的信心。

中國股市在二零二二年底的上漲勢頭延續至二零二三年上半年,因為有跡象顯示經濟正在反彈,尤其是服務業,在放寬新冠嚴格的控制後,服務業釋放報復需求。隨後,市場從一月份的高位向下波動,投資者情緒仍然反覆,所有市場人士都在關注經濟復甦路徑,製造業和房地產行業存有不明朗因素,仍然給市場帶來壓力。

Market Review (Continued)

In fixed income, Chinese government bond yields oscillated at a relatively low level before November 2022, then rose sharply amid early signs of loosening Covid controls and rising expectations on economic recovery, despite the still-loose liquidity stance from the PBoC. The CGB yields peaked in January 2023, then continued to grind lower driven by expectation on further policy easing amid uneven economic activity data releases.

Outlook

Sentiment towards China's economic recovery and financial markets has deteriorated since official April and May 2023 activity data undershot consensus forecasts, causing economic surprise indices to drop back from elevated levels. However, the economic recovery so far seems to be playing out largely in line with our expectations for a burst of fast growth, led by services with manufacturing and real estate lagging behind.

Indeed, there are tentative signs that as the drivers of growth will broaden out later in the year. Real estate sales have stabilised, led by Tier 1 cities, which would usually feed through to activity with a lag of 6-9 months and lead to some growth from a low base. And while manufacturing has been weak amid a general contraction in the goods side of the global economy, there are signs that global restocking will begin to support output and exports in the second half of the year. That would also be supportive for the RMB, which continues to trade in line with the export cycle.

市場回顧(續)

在固定收益方面,中國政府債券的孳息在二零二二年十一月之前在相對較低的水平波動,其後受惠於有初步跡象顯示會放寬新冠控制和經濟可望復甦而大幅上升,儘管中國人民銀行的流動性立場仍然寬鬆。中國政府債券的孳息在二零二三年一月見頂,其後公布經濟活動數據好壞不一,預期當局會進一步放寬政策,孳息繼續走軟。

展望

自中國於二零二三年四月和五月公布官方活動數據低於普遍預測以來,對中國經濟復甦和金融市場的信心惡化,導致經濟驚奇指數從高位回落。然而,到目前為止,經濟復甦似乎在很大程度上符合我們對快速增長的預期,其中服務業為首,製造業和房地產跟隨其後。

事實上,有初步跡象顯示,推動增長的層面今年較後期將會擴大,受一級城市帶動,房地產銷售已經回穩,房地產刺激經濟活動通常會在六至九個月的滯後時間,屆時可從低基數開始帶來一些增長。儘管在全球經濟商品方面普遍收縮況下,製造業一直疲弱,但亦有跡象顯示,全球補貨的需求將在今年下半年開始支持產出和出口,這也將支持人民幣,因為人民幣繼續按照出口週期進行買賣。

Outlook (Continued)

For the longer run, the post-Covid recovery together with supportive policy environment remain positive structural tailwinds for Chinese equities, and we kept our long positions in Chinese equity index futures. However, headwinds from uneven recovery and subdued inflation data concern the markets recently, and we are closely monitoring the recovery momentum. Elsewhere, we tactically favor Hong Kong equity index option exposures, to take advantage of upside potential in both the economic recovery and the valuation levels.

In terms of fixed income, we remain positive on the credit market for the rest of 2023. We believe that it will be a pure market until the year-end, with technicals potentially overriding weakening fundamentals and relatively-tight valuations. That being said, we recognise that downward pressure on fundamentals is building due to slower global economic growth, lingering problems for the China property sector, and recent adverse headline news on local government financing vehicles. Security selection is a key to generating alpha, and we prefer investment grade over high yield bonds.

展望(續)

從長遠來看,新冠疫情後經濟復甦,以及當局推 行支持性的政策,仍然是中國股市的結構性利好 因素,我們保持對中國股票指数期貨的長倉。然 而,中國復甦類別並非均衡分布,通脹數據疲 弱,帶來不利影響,最近令市場擔憂,我們正在 密切關注復甦勢頭。在其他方面,我們策略上看 好香港股票指數的期權投資,以利用經濟復甦和 估值水平的上行潛力。

就固定收益而言,在二零二三年的剩餘時間,我們對信貸市場保持樂觀。我們相信,在年底之前,市場將純粹以內部因素影響走勢,技術因素可能會壓倒疲弱的基本因素和相對過高的估值。話雖如此,我們認識到,由於全球經濟增長放緩、中國房地產行業的問題揮之不去,以及最近出現有關地方政府融資工具的不利消息,基本因素的下行壓力正在增加。證券選擇是產生超額回報的關鍵,我們看好投資級債券而不是高收益債券。

Report on the Audit of Financial Statements

Opinion

We have audited the financial statements of Schroder China Asset Income Fund ("the Fund"), a sub-fund of Schroder Umbrella Fund II, set out on pages 13 to 109, which comprise the statement of financial position as at 30th June 2023, the statement of comprehensive income, the statement of changes in net assets attributable to unitholders and the statement of cash flows for the year then ended and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the financial statements give a true and fair view of the financial position of the Fund as at 30th June 2023 and of its financial transactions and cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA").

Basis for Opinion

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the HKICPA. Our responsibilities under those standards are further described in the Auditor's responsibilities for the audit of the financial statements section of our report. We are independent of the Fund in accordance with the HKICPA's Code of Ethics for Professional Accountants ("the Code") and we have fulfilled our other ethical responsibilities in accordance with the Code. 1. GENERAL INFORMATION

Schroder China Asset Income Fund (the "Fund") is a sub-fund of Schroder Umbrella Fund II. Schroder Umbrella Fund II is an umbrella unit trust which is governed by its trust deed dated 8th October 2010. as amended (the "Trust Deed"), between Schroder Investment Management (Hong Kong) Limited (the "Manager") and HSBC Institutional Trust Services (Asia) Limited (the "Trustee"). The Fund is authorised by the Securities and Futures Commission of Hong Kong ("SFC") under Section 104(1) of the Hong Kong Securities and Futures Ordinance and is required to comply with the Code on Unit Trusts and Mutual Funds established by the Securities and Futures Commission of Hong Kong.

The Fund's objective is to provide income and capital growth by investing primarily in Chinese equity and fixed income securities.

The Fund will seek to achieve the investment objective primarily through investment in a portfolio of (a) equities and equity related securities of China and China related companies; and (b) bonds, convertible bonds and other fixed or floating rate securities issued by China and China related companies and governments, government agencies and supra-national issuers in mainland China. China and China related companies refer to companies which are headquartered and/or listed in or have a substantial business exposure to mainland China.

1. 一般資料

施羅德中國股債收息基金(「基金」)為施羅德率型基金II之子基金。施羅德率型基金II是根據一份由施羅德投資管理(香港)有限公司作為經理人(「經理人」)和滙豐機構信託服務(亞洲)有限公司作為受託人(「受託人」)簽署,日期為二零一零年十月八日的信託契約(經修訂)成立的傘型單位信託基金。本基金並已獲香港證券及期貨事務監察委員會設立之單位信託及互惠基金守則規範。

本基金的目標是主要通過投資於中國股票和 定息證券,以提供收益及資本增值。

本基金主要透過投資於包括(a)中國及中國相關公司的股票和股票相關證券;及(b)由中國及中國相關公司、及中國內地政府、政府機構和跨國家發行商發行的債券、可換股債券和其他定息或浮息證券的投資組合,尋求達致投資目標。中國和中國相關公司指其總部設於中國內地及/或於中國內地上市或在中國內地設有重要業務的公司。

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

(a) Basis of preparation

The financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants. The financial statements have been prepared under the historical cost convention, as modified by the revaluation of financial assets and financial liabilities (including financial derivative instruments) held at fair value through profit or loss.

The preparation of financial statements in conformity with HKFRS requires the use of certain critical accounting estimates. It also requires the Trustee and Manager to exercise their judgment in the process of applying the Fund's accounting policies. The areas involving a higher degree of judgment or complexity, or areas where assumptions and estimates are significant to the financial statements are disclosed in note 4.

(i) Assets

The Fund classifies its investments based on both the Fund's business model for managing those financial assets and the contractual cash flow characteristics of the financial assets. The portfolio of financial assets is managed and performance is evaluated on a fair value basis. The Fund is primarily focused on fair value information and uses that information to assess the assets' performance and to make decisions. The Fund has not taken the option to irrevocably designate any equity securities as fair value through other comprehensive income. The contractual cash flows of the Fund's debt securities are solely principal and interest, however, these securities are neither held for the purpose of collecting contractual cash flows nor held both for collecting contractual cash flows and for sale. The collection of contractual cash flows is only incidental to achieving the Fund's business model's objective. Consequently, all investments are measured at fair value through profit or loss.

The Fund makes short sales in which a borrowed security is sold in anticipation of a decline in the market value of that security, or it may use short sales for various arbitrage transactions. Short sales are held for trading and are consequently classified as financial liabilities at fair value through profit or loss. Derivative contracts that have a negative fair value are presented as liabilities at fair value through profit or loss.

As such, the Fund classifies all of its investment portfolio as financial assets or liabilities at fair value through profit or loss.

Recognition, derecognition and measurement

Purchases and sales of investments are accounted for on the trade date basis. Investments are initially recognised at fair value, excluding transaction costs which are expensed as incurred, and are subsequently re-measured at fair value. Realised and unrealised gains and losses on investments are included in the statement of comprehensive income in the year in which they arise. Investments are derecognised when the rights to receive cash flows from the investments have expired or the Fund has transferred substantially all risks and rewards of ownership.

Recognition, derecognition and measurement (Continued)

Subsequent to initial recognition, all financial assets and financial liabilities at fair value through profit or loss are measured at fair value. Gains and losses arising from changes in the fair value of the "financial assets or financial liabilities at fair value through profit or loss" category are presented in the statement of comprehensive income within net change in unrealised appreciation/depreciation in value of investments and financial derivative instruments in the period in which they arise.

Fair value estimation

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value of financial assets and liabilities traded in active markets are based on quoted market prices at the close of trading on the reporting date.

Investments that are listed or traded on an exchange are fair valued based on quoted last traded prices.

Investments which are not listed on an exchange or are thinly traded are valued by using quotes from brokers.

Investments in unit trusts or unlisted funds are valued at their net asset value per unit as provided by the administrators of such funds.

(c) Financial derivative instruments

Derivatives are recognised at fair value on the date on which a derivative contract is entered into and are subsequently remeasured at their fair value. Fair values are obtained from quoted market prices in active markets, including recent market transactions, and valuation techniques, including discounted cash flow models and option pricing models, as appropriate. All derivatives are carried as assets when fair value is positive and as liabilities when fair value is negative.

Subsequent changes in the fair value of any derivative instruments are recognised immediately in the statement of comprehensive income.

(d) Structured entities

A structured entity is an entity that has been designed so that voting or similar rights are not the dominant factor in deciding who controls the entity, such as when any voting rights relate to administrative tasks only and the relevant activities are directed by means of contractual arrangements. A structured entity often has some or all of the following features or attributes: (a) restricted activities. (b) a narrow and well-defined objective, such as to provide investment opportunities for investors by passing on risks and rewards associated with the assets of the structured entity to investors, (c) insufficient equity to permit the structured entity to finance its activities without subOrdinated financial support and (d) financing in the form of multiple contractually linked instruments to investors that create concentrations of credit or other risks (tranches).

(c) 金融衍生工具

(d) Structured entities (Continued)

The Fund considers all of its investments in other funds ("Investee Funds") to be investments in unconsolidated structured entities. The Fund invests in Investee Funds whose objective is to achieve long term capital growth. The Investee Funds are managed by one asset manager who applies various investment strategies to accomplish its investment objectives. The Investee Funds finance their operations by issuing redeemable shares which are puttable at the holder's option and entitles the holder to a proportional stake in the respective fund's net assets. The Fund holds redeemable shares in each of its Investee Funds.

The change in fair value of each Investee Fund is included in the statement of comprehensive income in "Net change in unrealised appreciation/depreciation in value of investments and financial derivative instruments".

(e) Income and expenses

Dividend income is recorded on the exdividend date with the corresponding foreign withholding taxes recorded as an expense.

Interest income is recognised on a time proportionate basis using the effective interest method.

Other income and expenses are accounted for on an accruals basis.

(f) Foreign currency translation

Functional and presentation currency

Items included in the financial statements are measured using the currency of the primary economic environment in which the Fund operates (the "functional currency"). The performance of the Fund is measured and reported to the unitholders in Hong Kong Dollar ("HK\$"). The Manager considers HK\$ as the currency that most faithfully represents the economic effects of the underlying transactions, events and conditions. The financial statements are presented in HK\$, which is the Fund's functional and presentation currency.

Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign currency assets and liabilities are translated into the functional currency using the exchange rate prevailing at the year end date.

Foreign exchange gains and losses arising from translation are included in the statement of comprehensive income.

Foreign exchange gains and losses relating to cash and cash equivalents are presented in the statement of comprehensive income within "net exchange gains/(losses)".

Foreign exchange gains and losses relating to the financial assets and liabilities carried at fair value through profit or loss are presented in the statement of comprehensive income within "net realised gains/(losses) on disposal of investments and financial derivative instruments" and "net change in unrealised appreciation/ depreciation in value of investments and financial derivative instruments".

(g) Offsetting financial instruments

Financial assets and liabilities are offset and the net amount is reported in the statement of financial position when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis, or realise the asset and settle the liability simultaneously.

The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the Fund or the counterparty.

(h) Amounts receivable on disposal/payable on purchase of investments

Amounts receivable on disposal/payable on purchase of investments represent receivables for investments sold and payables for investments purchased that have been contracted for but not yet settled or delivered on the statement of financial position date respectively.

(i) Receivables

Receivables are recognised initially at fair value and subsequently measured at amortised cost. At each reporting date, the Fund shall measure the loss allowance on amounts due from counterparties at an amount equal to the lifetime expected credit losses if the credit risk has increased significantly since initial recognition. If, at the reporting date, the credit risk has not increased significantly since initial recognition, the Fund shall measure the loss allowance at an amount equal to 12-month expected credit losses.

(i) Receivables (Continued)

Significant financial difficulties of the counterparties, probability that the counterparties will enter bankruptcy or financial reorganisation, and default in payments are all considered indicators that a loss allowance may be required. If the credit risk increases to the point that it is considered to be credit impaired, interest income will be calculated based on the gross carrying amount adjusted for the loss allowance. A significant increase in credit risk is defined by management as any contractual payment which is more than 30 days past due. Any contractual payment which is more than 90 days past due is considered credit impaired.

Receivables are classified as current assets if the collections of receivables are expected within one year. If not, they are presented as non-current assets.

(j) Payables and accruals

Payables and accruals are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method. Payables and accruals are classified as current liabilities if payment is due within one year or less. If not, they are presented as non-current liabilities.

(k) Distributions payable

Proposed distributions to unitholders are recognised in the statement of comprehensive income when they are appropriately authorised by the Manager and no longer at the discretion of the Fund. The distribution on the redeemable units is recognised as a finance cost in the statement of comprehensive income.

(I) Cash and cash equivalents

Cash and cash equivalents include cash in hand, bank and demand deposits, other short-term highly liquid investments with original maturities of three months or less and bank overdrafts, if any.

(m) Margin accounts

Margin accounts represent margin deposits held in respect of open futures contracts.

(n) Redeemable units

Redeemable units of the Fund are classified as financial liabilities and are issued or redeemed at the holder's option at prices based on the Fund's net asset value per unit as at the close of business on the relevant dealing day. The Fund's net asset value per unit is calculated by dividing the net assets attributable to the unitholders with the total number of outstanding units.

(a) Strategy in using financial instruments

The Fund's objective is to provide income and capital growth by investing primarily in Chinese equity and fixed income securities.

The Fund will actively allocate between Chinese equities, Chinese fixed income securities, other asset classes and cash to achieve the Fund's objectives. The Fund's expected asset allocation ranges for each asset class is expected to be the following:

(b) Market price risk

Market price risk is the risk that the value of a financial instrument will fluctuate as a result of changes in market prices, whether those changes are caused by factors specific to the individual instrument or factors affecting all instruments in the market.

All investments present a risk of loss of capital. The Fund's market price risk is managed through diversification of the investment portfolio. The Fund's overall market positions are monitored on a regular basis by the Manager.

As 30th June 2023, the Fund had bank balances of HK\$64,893,849 (2022: HK\$211,195,799) and the margin deposits with interest bearing of HK\$70,113,560 (2022: HK\$71,730,924). No sensitivity analysis is prepared as the bank balances and margin deposits are short term in nature, and are therefore exposed to minimal interest rate risk on these balances.

Credit risk is the risk that an issuer or counterparty will be unable or unwilling to meet a commitment that it has entered into with the Fund.

The Fund's financial assets which are potentially subject to concentrations of credit risk consist principally of bank deposits and assets held with the custodian.

The Fund limits its exposure to credit risk by transacting the majority of its investments and contractual commitment activities with broker-dealers, banks and regulated exchanges with high credit ratings and that the Fund considers to be well established.

All transactions in investments are settled/paid for upon delivery using approved and reputable brokers. The risk of default is considered minimal as delivery of investments sold is only made once the broker has received payment. Payment is made on a purchase once the investments have been received by the broker. The trade will fail if either party fails to meet its obligation.

The Fund measures credit risk and expected credit losses using probability of default, exposure at default and loss given default. Management consider both historical analysis and forward looking information in determining any expected credit loss. (f) Liquidity risk

Liquidity risk is the risk that an entity will encounter difficulty in settling its liabilities, including a redemption request.

The Fund is exposed to daily cash redemptions of redeemable units. The Fund invests the majority of its assets in investments that are traded in an active market and are considered to be readily realisable.

The Fund also invests in financial derivative instruments and debt securities that are traded over the counter. As a result, the Fund may not be able to liquidate quickly its investments in these instruments at an amount close to their fair value to meet its liquidity requirements due to adverse market conditions leading to limited liquidity. It is the intent of the Manager to monitor the Fund's liquidity position on a daily basis.

The Manager is entitled to limit the number of units to be redeemed on any one dealing day to 10% of the units in issue (with redemption requests reduced pro rata) and any excess redemption requests are then carried forward to the next dealing day. The Manager or the Trustee may at any time suspend the right of unitholders to redeem units and will at the same time cease to issue units in certain circumstances as mentioned in the Explanatory Memorandum.

The carrying value less impairment provision of other receivables and payables are assumed to approximate their fair values. Financial instruments that trade in markets that are not considered to be active but are valued based on quoted market prices, dealer quotations or alternative pricing sources supported by observable inputs are classified within level 2.

Investments classified within level 3 have significant unobservable inputs, as they trade infrequently. As of 30th June 2023 and 2022, the Fund did not hold any investments classified in level 3.

For the years ended 30th June 2023 and 2022, there were no transfer between levels of investments held by the Fund.

The financial assets and liabilities included in the statement of financial position, other than investments and financial derivative instruments, are carried at amortised cost; their carrying values are a reasonable approximation of fair value. There are no other assets or liabilities not at fair value but for which the fair value is disclosed.

The capital of the Fund is represented by the net assets attributable to unitholders. The amount of net assets attributable to unitholders can change significantly on a daily basis as the Fund is subject to daily subscriptions and redemptions at the discretion of unitholders. The Fund's objective when managing capital is to safeguard the Fund's ability to continue as a going concern in order to provide returns for unitholders and benefits for other stakeholders and to maintain a strong capital base to support the development of the investment activities of the Fund.

In order to maintain or adjust the capital structure, the Fund policy is to perform the following:

- monitor the level of daily subscriptions and redemptions relative to the liquid assets; and
- redeem and issue units in accordance with the trust deed of the Fund, which includes the requirement of minimum redemption amount of HK\$5,000 for HKD denominated accumulation and distribution units of Class A, RMB5,000 for RMB denominated distribution units of Class A and US\$1,000 (or equivalent value in other currencies) for accumulation and distribution units of Class A denominated in a currency other than HKD or RMB.

4. CRITICAL ACCOUNTING ESTIMATES AND JUDGMENTS

Management makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. Estimates are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are outlined below.

Fair value of unlisted investments

As at 30th June 2023 and 2022, the Fund held a number of derivatives that were valued by reference to broker quotes. In determining the fair value of such investments, the Trustee and the Manager exercise judgments and estimates on the sources of brokers and the quantity and quality of broker quotes used. Such broker guotes adopted to fair value the investments may be indicative and not executable or legally binding. As such, broker quotes do not necessarily indicate the price at which the security could actually be traded as of 30th June 2023 and 2022. Actual transacted prices may differ from the broker quotes provided by the brokers. The Trustee and the Manager consider that in the absence of any other reliable market sources, the broker quotes available to them reflect the best estimate of fair value.

6. TRANSACTION COSTS

6. 交易成本

Transaction costs are costs incurred to acquire/dispose financial assets or liabilities at fair value through profit or loss. They include the bid/ask spread, fees and commissions paid to agents, advisers, brokers and dealers.

7. MARGIN ACCOUNTS

Margin accounts represent margin deposits held in respect of open futures contracts. As at 30th June 2023, the Fund held margin deposits of HK\$70,113,560 (2022: HK\$71,730,924) of which HK\$19,519,542 (2022: HK\$53,064,899) is restricted.

8. MANAGEMENT FEE AND TRUSTEE FEE

Management fee and trustee fee are charged by Schroder Investment Management (Hong Kong) Limited and HSBC Institutional Trust Services (Asia) Limited respectively.

Management fee is currently charged at a rate of 1.50% per annum for Class A with an allowable maximum rate of 7% per annum of the net asset value of the Fund. No management fee is charged to Class I.

The trustee fee for the Fund is 0.07% per annum of the net asset value of the Fund subject to a minimum fee of HK\$156,000 per annum, with an allowable maximum rate of 0.50% per annum of net asset value of the Fund.

These fees are accrued daily on each valuation date and payable monthly in arrears.

As at 30th June 2023, management fee payable and trustee fee payable amounted to HK\$3,794,226 (2022: HK\$4,675,115) and HK\$240,106 (2022: HK\$279,079) respectively.

Total management fee and trustee fee for the year amounted to HK\$51,727,874 (2022: HK\$64,929,950) and HK\$3,180,285 (2022: HK\$3,844,856) respectively.

7. 保證金戶口

9. DISTRIBUTIONS

(a) Accumulation units

The Manager shall not make any distributions of income or net capital gains realised on the sale of investments in respect of the accumulation units. Any income and net capital gains in respect of the accumulation units shall be accumulated and capitalised.

(b) Distribution units

In respect of distribution units, the Manager will declare and pay monthly distributions on such date as may be determined by the Manager. However, the distribution rate is not guaranteed. In the event that the income generated from the Fund's investments attributable to the relevant Class of the Distribution Units during the relevant period is insufficient to pay distributions as declared, the Manager may in its discretion determine such distributions be paid from capital.

The Manager will periodically review distribution units and reserve the right to make changes to the distribution policies of the distribution units. Any change to the frequency of distributions is subject to one month's prior notice to the relevant unitholders. If the Manager does not intend to retain the flexibility to pay distributions out of the amount originally invested or income attributable to the prior year of the Fund, the change will be subject to the SFC's prior approval and one month's prior notice to the relevant unitholders.

11. TAXATION

(a) Hong Kong Tax

No provision for Hong Kong profits tax has been made as the Fund was authorised as a collective investment scheme under Section 104 of the Hong Kong Securities and Futures Ordinance and is therefore exempt from Hong Kong profits tax under Section 26A (1A) of the Hong Kong Inland Revenue Ordinance.

(b) Mainland China Tax

The Fund invests in shares of companies in mainland China listed on overseas stock exchanges including the H-shares listed on the Hong Kong Stock Exchange ("H-shares"). Under the mainland China Corporate Income Tax Law, the Fund may be liable to pay mainland China tax on the capital gains realised in the trading of H-shares. However, no provision was made for taxation from such gains in the financial statements as the Trustee and the Manager believe that the Fund can sustain a position for not filing a tax return based on the existing tax regulations and that the enforcement of mainland China tax on capital gains is not probable.

(c) Withholding Tax

Withholding tax was charged on certain dividend received and interest income during the year.

11. 稅項

The Fund's is shown net assets attributable to unitholders in the statement of financial position. Subscriptions and redemptions of units during the year are shown in the statement of changes in net assets attributable to unitholders. In order to achieve the investment objectives, the Fund endeavors to make investment in accordance with the investment policies as outlined in note 3, whilst maintaining sufficient liquidity to meet redemption requests. Such liquidity is augmented by the holding of liquid investments.

In accordance with the provisions of the Fund's Trust Deed dated 8th October 2010, as amended, and Explanatory Memorandum, investments are stated at the last traded price on the valuation day for the purpose of determining net asset value per unit for subscriptions and redemptions and for various fee calculations.

Net assets attributable to unitholders represent a financial liability in the statement of financial position, carried at the redemption amount that would be payable at the year end date if the unitholder exercised the right to redeem the units in the Fund.

The overdraft facility is the lesser of US\$10,800,000 or 3% of the net asset value of the Fund. The overdraft balance shall bear interest at 0.6% above HSBC's best lending rate for USD and CNY; 2% over HSBC's best lending rate for CAD, GBP, EUR, SGD, JPY, NZD and AUD; 1.625% below HSBC's best lending rate for HKD. As at 30th June 2023 and 2022, there was no outstanding payable under the overdraft facility.


