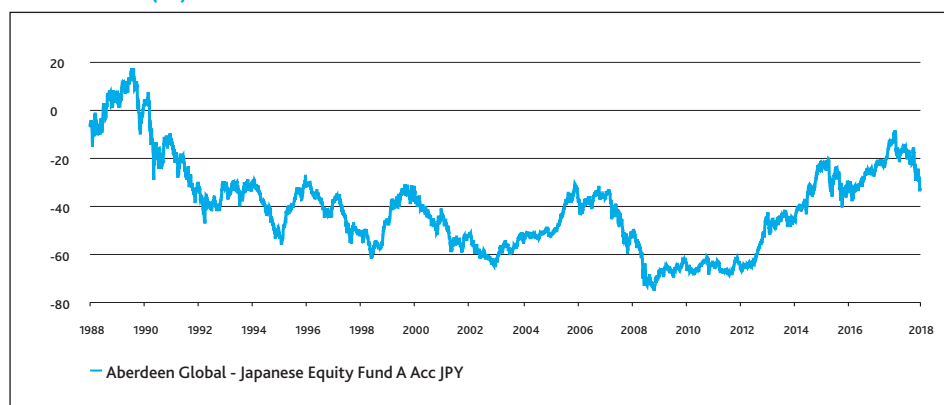
Investment objective

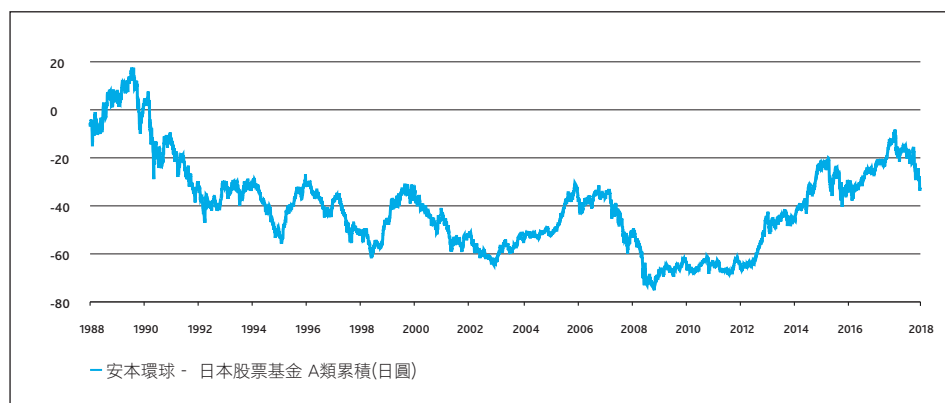
