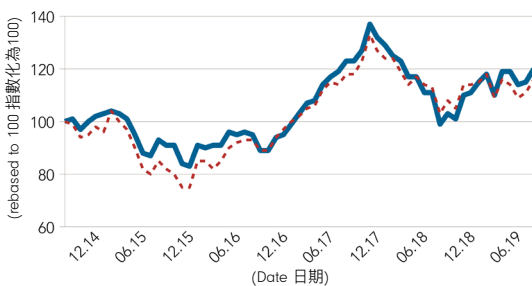

- This fund invests primarily in equity securities in Latin America, South East Asia, Africa, Eastern Europe (including Russia) and the Middle East.

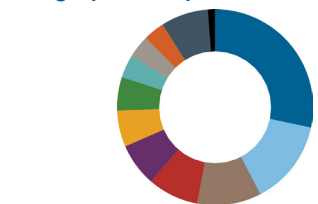

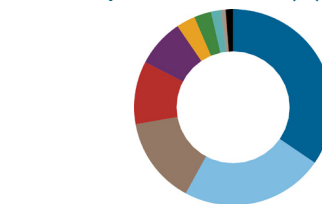
