### Important Information 重要事項

The fund invests primarily in equity and equity related securities of companies in countries participating in the EMU.

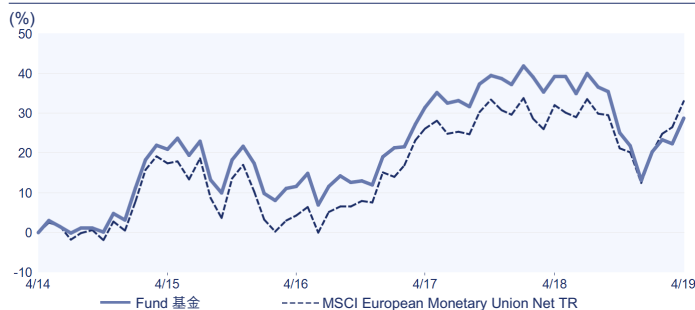
### Investment Objective 投資目標
