### Important Information

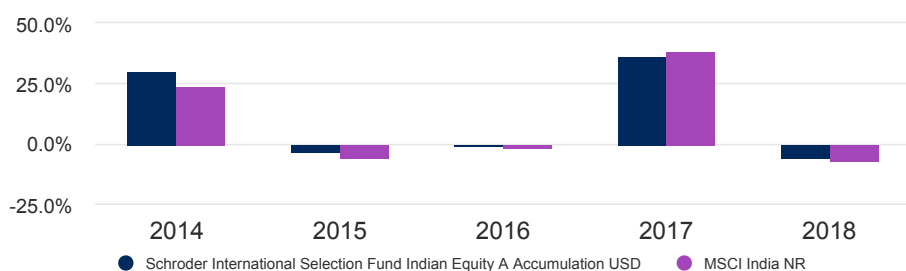

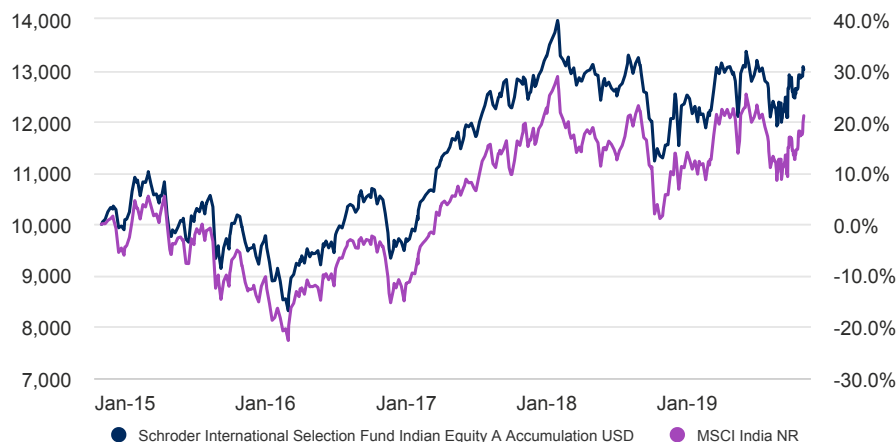

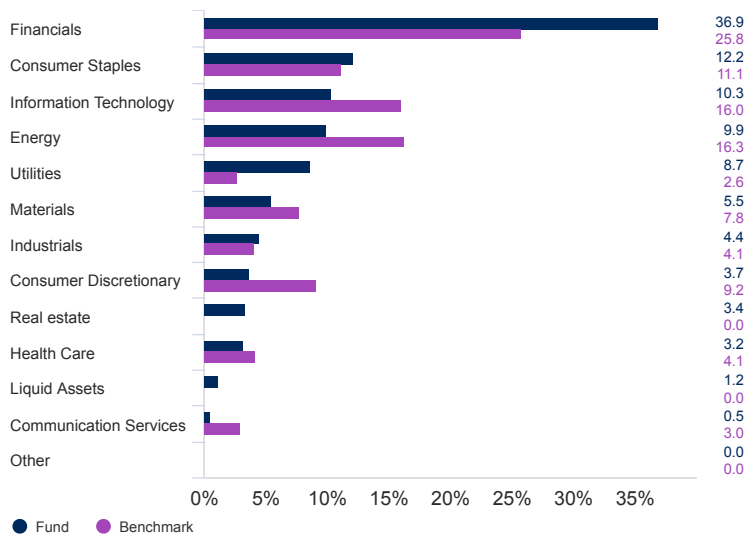

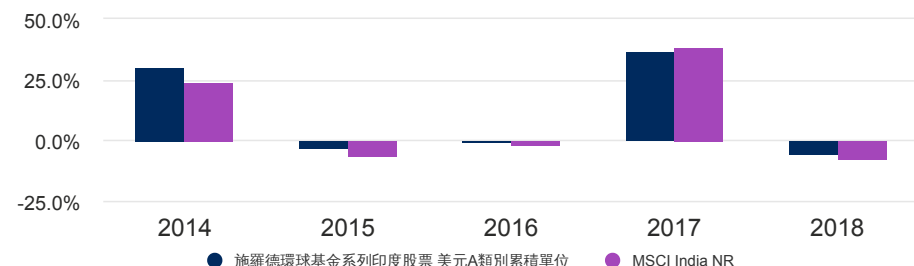

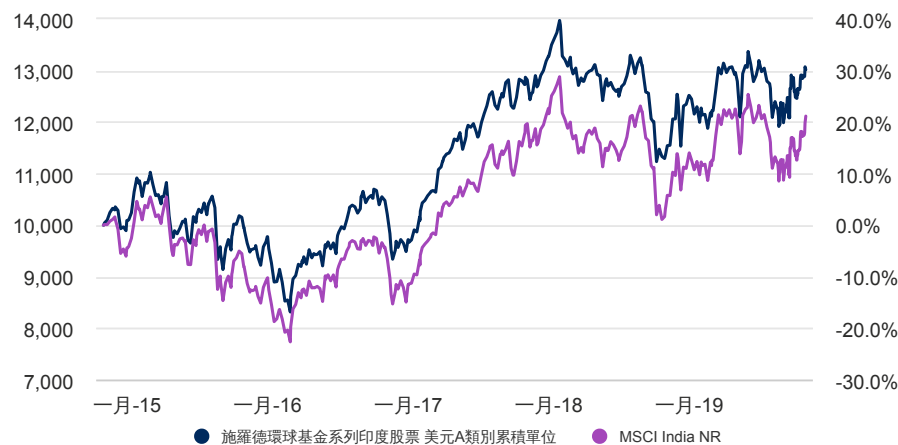

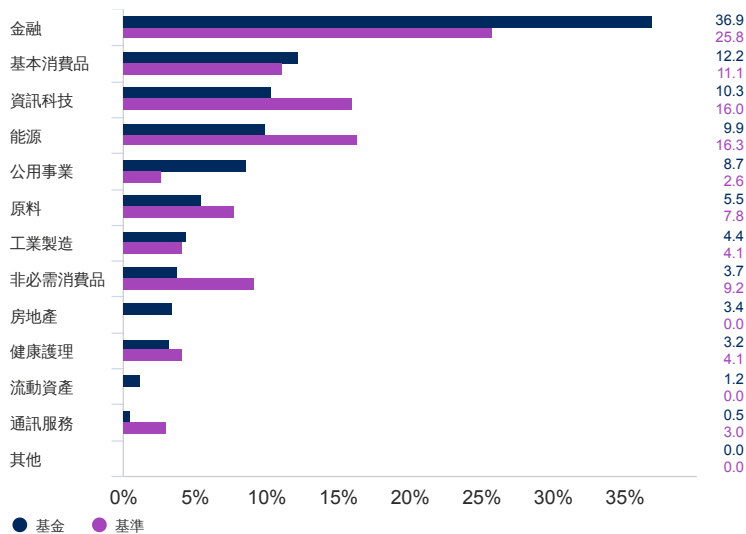
